**Abstract**

The Donald Judd Papers document the studio practice and personal activities of the artist including art fabrication, property acquisitions, exhibitions, writings, and publications. With a bulk of the records dating from 1939-1994, items include correspondence; handwritten drafts and notes; legal records such as agreements, court documents, and deeds; a large volume of printed material (maps, catalogues, travel ephemera, postcards, newspapers, clippings, etc.); drawings; photographic material; and extensive documentation of Judd's financial obligations and activities including travel expenses, fabrication invoices and purchase orders, household expenses, employee wages, tax obligations, banking records, and mortgage and insurance payments.

Predominantly English, with some material in German, French, Russian, Spanish, Korean, Japanese, Danish, Dutch, Finnish, French, Greek, Icelandic, Italian, and Swedish.

### **Processing Information**

Collection process by Judd Foundation Archives staff from 2021-2023 through a major project supported by a grant from the National Endowment for the Humanities. Processing was led by Irene Lule and Caitlin Murray.

### **Lifetime and Post-Lifetime Materials**

Following Judd's death on February 12, 1994, the Donald Judd Estate was created to settle Judd's activities at the time of his death as well as any legal claims. Judd Foundation was legally established in 1996 by the Trustees of the Donald Judd Estate. During the years of the Donald Judd Estate (1994-2000) and the early years of Judd Foundation, staff intermixed records created by the Estate in the years immediately after Judd's death with records created by Judd and his studio. Throughout the Donald Judd Papers, there are post-lifetime materials mixed with lifetime materials and files created after Judd's death that contain lifetime documents. These materials were reviewed on a case-by-case basis to determine their appropriate arrangement within the Donald Judd Papers or possible movement to the Donald Judd Estate and Early Judd Foundation Records. Areas that were heavily used by the Estate include financial records (Financial, Employee, and Legal Records series) and materials related to properties (Architecture and Spaces subseries). If you are interested in any material from 1992-1996, please carefully read the Scope and Content notes for each series and consult the Archivist.

### **Processing Notes**

Careful attention was paid to accessibility, use, and existing original order when present. Please read the Scope and Content sections of each series for more detailed information. All original folders were photocopied, and these photocopies were placed at the beginning of the new archival folders for context. Due to their size, only folders with Judd handwriting and/or extensive handwriting by his staff were kept with the original material. Any sticky notes found were photocopied on archival paper. Additionally, any sticky notes covering text or in fragile condition were removed and rehoused in polyester sleeves.

### **Special Collections**

Due to their fragility, rarity, and handling requirements, drawings created by Donald Judd, photographs, and material samples found in the Donald Judd Papers have been replaced by photocopies. Drawings by Donald Judd and photographs were moved to Special Collections; material samples were moved to Collections. Please consult the Archivist to view Special Collections or Collections items.

**Works** consist of materials related to Donald Judd's activities in art, architecture, furniture, and design. Materials include correspondence, drawings, photographs, handwritten notes, blueprints, legal documents, financial documents such as invoices and receipts, and printed material. The bulk of this material was created and maintained by Judd's studio. In some cases, original folders were created by Judd or the Donald Judd Estate. The Works series includes four subseries: Artwork; Architecture and Spaces; Furniture; and Design.

### **Subseries A. Artwork, 1959-1999, undated**

The **Artwork** subseries relates to the creation, commissioning, and sale of Judd's work in painting and objects. Records pertaining to paintings consist of one folder. The bulk of the records in this subseries document the creation of objects, including fabricator, studio, and materials records.

Consisting of 13 boxes, Fabricator Records for Objects document the production of and payment for the fabrication of Judd's works in three dimensions. Created and maintained by the studio, these records are arranged alphabetically by fabricator, then chronologically by year. Fabrication entities include businesses (e.g., Bernstein Brothers Inc., Lippincott, Inc.), individuals (e.g., Peter Ballantine, Celedonio Mediano), and cities or entities that commissioned works (e.g., Münster). Materials in these folders often follow a standard arrangement: purchase orders, invoices, correspondence, drawings, and restoration-related documents. Whereas purchase orders were created by the studio to document the ordering of a work, invoices were typically generated by the fabricator. Correspondence consists of handwritten notes created by studio assistants and correspondence primarily between the studio and fabricator. Drawings largely consist of photocopies made by Judd's studio assistants of his original drawings or drawings by fabricators. Records documenting the restoration of works consist primarily of photocopied invoices or purchase orders created for pieces undergoing restoration. For these documents, please look for keywords that specify the form of remediation.

The Fabricator Records section includes records that had been left in situ in Judd's Art Studio in Marfa. Due to its unique arrangement, the found order was maintained. Original records were removed by the Archives staff in 2021 and replaced by surrogates. Additionally, the Fabricator Records subseries includes records that originated from Lippincott, Inc. and were provided to Judd Foundation after Judd's death. These records consist of photocopies of drawings, invoices, correspondence, and notes created by the company.

Fabricator Records are closed until the completion of the Donald Judd Catalogue Raisonné Project. Please consult the Archivist ([archives@juddfoundation.org](mailto:archives@juddfoundation.org)) for questions or additional information.

Studio Records for Objects consists of eight boxes of files created and maintained by Judd's studio assistants that pertain to the creation and tracking of artworks, including restoration files, records documenting various types of works (unrealized, destroyed, canceled, fakes), and material files. The bulk consists of records created by Dudley Del Balso (Judd's assistant from 1968-1983), with additional records created by Ellie Meyer (Judd's assistant from 1983-1991). These files include correspondence, financial records, drawings, photographs, notes, and printed material that was arranged topically. Of particular interest are research files that document updates

to Judd's 1975 catalogue raisonné and files that form the Running Record, a system created by Del Balso to track fabrication.

Two categories on prints and works in edition, the Roy C. Judd Files and Studio Records for Prints and Works in Edition, relate to the design, fabrication, sale, and loan of woodblocks, prints, and multiples made between 1963 and 1993. The material consists of correspondence, drawings, and handwritten notes with a small amount of printed material. The bulk of these materials relates to prints, with a small quantity of files related to works in edition. Original order was maintained where present; however, the bulk of the records were rehoused by Judd Foundation staff prior to processing in 2021-2023. Approximately half of the material pertains to Judd's father Roy C. Judd's involvement in the production and documentation of woodblock prints. Other fabricators represented include Gemini G.E.L. in Los Angeles, Jim Cooper/Ichiro Kato in New York, and Arber & Sons Editions in New Mexico. This material also contains correspondence between Judd's studio assistants (primarily Dudley Del Balso, but also Jamie Dearing and Rob Weiner) and dealers, institutions, and collectors.

The Roy C. Judd Files include correspondence between Roy and studio assistants Dudley Del Balso and Jamie Dearing; Roy and staff at the National Gallery of Canada; and ledgers, drawings, and invoices. Roy C. Judd's notebooks, which were transferred from his possession to the studio in the 1970s and 1980s, include details on the materials, dimensions, and construction of work in three dimensions, woodblocks, and woodblock prints. These records document the number of prints he made from each block over time. Also included is a folder with drawings by Roy C. Judd for woodblocks that were never produced. The bulk of these records date to 1978.

Studio Records for Prints and Works in Edition consists of files created and maintained by studio assistants for the production, exhibition, and sale of prints and multiples. The bulk of the records are arranged by their Schellmann number (as listed in *Donald Judd: Prints and Works in Editions; A Catalogue Raisonné\**) for greater accessibility and use. These files include correspondence and notes from printers. Additional folders reflect realized and unrealized projects, financial documents from accountant Rubin L. Gorewitz, and potential printers and paper supplies/suppliers.

\*A catalogue raisonné for Judd's prints and works in edition was published 1993, with a second edition published in 1996, both by Edition Schellmann.

### **Subseries B. Architecture and Spaces, 1951, 1968-1999, undated**

Architecture and Spaces pertains to architectural projects and spaces created by Judd, both on property he owned or leased and commissioned projects for others. The term “spaces” has been used for this subseries title rather than “properties” to reflect the term Judd used. Materials were arranged alphabetically by project or space name. To improve accessibility, artificial folders were created for projects and spaces that had a small quantity of materials that were previously dispersed across the records.

There are five boxes of materials related to the ownership and maintenance of 101 Spring Street, the first building Judd purchased, in 1968 in New York. Titles, insurance, and mortgage information are gathered into two folders. Approximately three boxes relate to the maintenance of 101 Spring Street, including materials for

features of the building such as the molding, sprinkler system, and chimney. Additional files related to City of New York departments (Fire, Buildings, Transportation, etc.) document inspections and violations. There are several general utilities folders created by the studio that pertain to a variety of activities and businesses involved in the maintenance of the building. Items found in these folders consist mainly of correspondence, receipts, invoices, and handwritten notes. Note that additional records pertaining to the maintenance and upkeep of 101 Spring Street are in the Expenditures section of the Financial, Employee, and Legal Records series. Due to the importance of early titles, insurance, and mortgage information, these two aforementioned folders were placed at the beginning of the arrangement. All other materials pertaining to 101 Spring Street were grouped together by topic in alphabetical order.

In 1989, Judd hired the firm of Sean West Sculley to begin restoration of 101 Spring Street. Materials pertaining to the Sculley project were separated into two sections: correspondence and blueprints. The correspondence folders also include financial and legal documents. There is a single folder from Mike Howard, an early employee of Judd who performed basic building maintenance from May to July 1970 with early photos of the interior of 101 Spring Street included.

Beginning in 1976, throughout the 1980s, and principally from 1989 to 1991, Judd purchased extensive areas of ranch land south of Marfa, Texas. Records pertaining to Ayala de Chinati, the name Judd gave to his ranch, consist primarily of photocopies of legal documents such as purchaser's statements and deeds, correspondence, financial documents compiled after Judd's death, and associated legal obligations. Also included in this section are land acquisitions for three sections located on the Rio Grande/Río Bravo that were not part of Ayala de Chinati. Folders were arranged by purchase date and include the last name of the seller. In some cases, material for certain ranch purchases were dispersed across different boxes and folders. To increase accessibility and use, these materials were combined into single folders reflecting the purchase.

The three folders for La Mansana de Chinati/The Block, Judd's main living and working complex in Marfa, include titles, taxes, and files pertaining to the construction of the adobe walls that Judd added to the complex. Along with La Mansana de Chinati/The Block, Judd purchased several buildings in Marfa, mainly in the late 1980s and early 1990s. These include the Marfa National Bank (which Judd converted into the Architecture Studio), a former Safeway grocery store (Art Studio), a hotel (Print Building), and additional buildings downtown. Most of the materials for these spaces are photocopies of financial and legal documents compiled for inventory purposes after Judd's death. As with materials from Ayala de Chinati, records were occasionally dispersed and then combined by space.

Architectural projects with extensive documentation include the Bahnhof Ost Basel (Peter Merian Haus) in Basel, Switzerland; Winterthur Fountains in Winterthur, Switzerland; and Eichholteren, Judd's home and studio, in Küssnacht am Rigi, Switzerland. These materials include blueprints, correspondence, photographs, drawings, financial and project documents, and printed material. For Eichholteren, there are files created during Judd's lifetime and several created after his death by the Donald Judd Estate to identify and document Judd's personal effects.

This subseries also includes materials pertaining to projects Judd worked on with European museums. These include the design of a floor for the Lange Voorhout Palace (The Hague, Netherlands) and a room redesign for the Österreichisches Museum für Angewandte Kunst (MAK – Museum of Applied Arts, Vienna, Austria). For additional correspondence and context on the project at the MAK, please refer to the corresponding MAK folder in the Museums, Galleries, and Collectors series. For additional information on the Lange Voorhout Palace project, please see the Adrian Jolles Papers and the Haags Gemeentemuseum (now Kunstmuseum Den Haag) folders in the Museums, Galleries, and Collectors series.

A small quantity of general folders have been arranged in alphabetical order. These items include financial documents, correspondence, photocopies of plans and sketches by Judd, maps, surveys, and commissions.

The Donald Judd Estate made heavy use of materials related to these spaces due to the financial and legal obligations present after Judd's death. Most of the material related to Ayala de Chinati and Marfa acquisitions



are photocopies of original documents compiled by the Estate, with the originals located in the Donald Judd Estate and Early Judd Foundation Records. Please consult the finding aid for the Donald Judd Estate and Early Judd Foundation Records for more information.

Note that there are two properties Judd purchased or leased for which there are no records in this series: 53 East Nineteenth Street, New York, and Vienna Secession. Please review the Financial, Employee, and Legal Records series and Biographical Materials series for more information on these spaces, and the Special Collections of the Judd Foundation Archives for related drawings by Judd. See the Museums, Galleries, and Collectors series for information pertaining to the Chinati Foundation.

### **Subseries C. Furniture, 1979-1995, undated**

The **Furniture** subseries pertains to the design, distribution, loan, and sale of furniture designed by Judd. Records include drawings (primarily photocopies), fabricator files, correspondence, gallery files, financial

records, printed material, and several files from Hester van Royen, a dealer based in London who worked closely with the studio in promoting and selling Judd furniture throughout Europe from the late 1980s to 1994.

Also present in this subseries are two general correspondence folders, primarily containing letters and notes from the studio to fabricators, galleries (A/D, Formatera, Galerie Artificial, and Pace), dealers, and other interested parties; a single folder of general correspondence related to additional galleries (Ace/Doug Christmas, Criterio, LIMN, de Vera, Galerie Ulrich Fiedler, and BD Madrid); materials pertaining to shipping and loan of furniture; publication files concerning the design, drafts, correspondence, and rights for a furniture retrospective catalogue created in collaboration with the Museum Boymans-van Beuningen (now Museum Boijmans Van Beuningen); two folders of studio notes reflecting various topics concerning Judd furniture and loose handwritten notes by Dudley Del Balso, Judd, and an unidentified individual; and a single folder containing a small quantity of printed material.

**Subseries D. Design, 1971-1994, undated**

The **Design** subseries reflects Judd's work on several object designs, including water bottles, toys, porcelain dishes, jewelry, and windmills. These materials primarily consist of correspondence concerning commissions. Drawings, contracts, and printed material are also present. **Subseries C. Dia Art Foundation Records, 1974-1990, 1994, undated**

The **Dia Art Foundation Records** subseries relates to the conception and execution of large-scale, permanent installations of artwork in Marfa. These installations, originally referred to as the Dia Marfa Project and later known as the Art Museum of the Pecos, would eventually open to the public independently in 1986 as the Chinati Foundation (see The Chinati Foundation subseries). These records document the institutional relationship between Judd and Dia Art Foundation (formerly the Lone Star Foundation), based in New York and founded by Heiner Friedrich, Philippa Pellizzi, and Helen Winkler.

Included in this subseries are documents related to installations of artwork by Judd, John Chamberlain, Dan Flavin, and Barnett Newman; administrative memoranda between Dia Art Foundation offices in Marfa and New York; correspondence between Judd, his assistants, Heiner Friedrich, and third parties; legal agreements and correspondence between Judd and Dia Art Foundation; financial documents; printed material; and documents related to the establishment of archives in Marfa. These records have been arranged into the following categories: Works and Projects; Correspondence; Dia/Marfa Activity Reports; Donald Judd's Working Records; Legal Records; Financial Records; and Printed Material.

#### **Subseries D. The Chinati Foundation/La Fundación Chinati, 1986-1994, undated**

**The Chinati Foundation/La Fundación Chinati** subseries includes administrative records, correspondence, financial records, insurance records, and printed material pertaining to the Chinati Foundation. Prior to 1986, this initiative was also known as the Dia Marfa Project and Art Museum of the Pecos.

Administrative records consist of meeting agendas and notes, nonprofit paperwork, budgets, handwritten notes, drafts of promotional material, and party invitation lists. Correspondence is composed of letters and faxes regarding repairs, property purchases, artwork acquisitions, and event planning. Financial records consist of account statements, tax documents, inventories, payroll, tax deposit coupon books, and receipts. Insurance records include paperwork related to various insurance policies held by the foundation over the years. Printed material includes postcards, invitations, posters, brochures, exhibition ephemera, and newspaper articles.

In addition to material concerning Judd, this subseries contains material relating to artists who exhibited at the Chinati Foundation, including Josef Albers, Ingólfur Arnasson, John Chamberlain, El Lissitzky, Günther Förg, Roni Horn, Richard Paul Lohse, Ilya Kabakov, Richard Long, Agnes Martin, Piet Mondrian, Barnett Newman, Claes Oldenburg, Jan Schoonhoven, John Wesley, as well as artists-in-residence.

The **Writings and Publications** series contains handwritten and typed drafts and photocopies of reviews, essays, published letters, and notes by Judd, as well as drafts, proofs, correspondence, corrections, and notes related to publications made by or associated with him. Additionally, correspondence, exhibition ephemera, clippings, and photocopies appear throughout.

**Subseries A. Writings, 1959-1993, undated**

The **Writings** subseries is organized into five categories: Reviews, Essays and Letters, Notes, Journals, and Photocopies. These categories were created and maintained by Judd and/or his studio and were maintained here as such. Each category was originally organized in loose chronological order, which has been maintained and clarified when possible. The bulk of the notes were organized by Judd by year, and occasionally into groups of notes with varying dates. This is most common in the notes structured by inclusive dates.

The category Reviews reflects the period between 1959 and 1965 when Judd worked as an art critic. Reviews listed as “unidentified” refer to those that did not correspond to published or known reviews. The Notes category reflects writings composed as part of Judd’s semi-regular daily writing practice. The bulk of the notes were unpublished during his lifetime. The Photocopies category documents the studio practice of making photocopies of notes, essays, and letters so Judd could have them on hand in other locations, such as his ranch houses south of Marfa and his homes and studios in Germany and Switzerland. The nomenclature system for these folders, created by Judd and written in his hand, is often idiosyncratic.

The bulk of the Writings subseries was transcribed and published in *Donald Judd Writings* (Judd Foundation/David Zwirner Books, 2016). There is unpublished material throughout this subseries.

The Museums, Galleries, and Collectors series also includes materials pertaining to Judd’s contributions to publications (e.g., see the Museum Boymans-van Beuningen for information pertaining to *Donald Judd Furniture: Retrospective*, as well as the Furniture category of the Works series).

### **Subseries C. Civic Activities, circa 1940s-1994, undated**

One of the larger subseries, **Civic Activities** covers the broad range of organizations and causes Judd was involved in starting in the 1960s.

The first category, Organizations, records Judd's involvement with different civic, activist, and politically minded groups. Files are arranged in alphabetical order by organization name. Much of Judd's involvement was through writing letters of support, donating money or artwork for benefit exhibitions, or, in the case of the War Resisters League, hosting benefit exhibitions at 101 Spring Street. Some of the files contain only minor correspondence, donation letters, and/or newsletters sent by the organization. Other files indicate Judd's deep or prolonged involvement through personal correspondence and reports and agendas for boards he served on, including the Texas Advisory Board for the Environmental Defense Fund and the Board of Visitors for the McDonald Observatory. One of the most extensive files is the Citizens for Local Democracy, Lower-Manhattan Township, in which Judd and Julie Finch were highly involved. This includes meeting minutes and reports, extensive manuscripts and drafts, and published versions of writings for the group's publications, some with Julie Finch's handwritten drafts.

The second subset of Civic Activities, Political and Civic Involvement and Interests, relates to Judd's interests in local political issues in Marfa, New York, and national or general issues. These files document his support for various political campaigns, including Commissioner Jim Hightower for Texas Department of Agriculture and United States Senator Edward M. Kennedy. Marfa concerns include a file of complaints regarding air traffic over Judd's ranch and a legal file for noise complaints against Tom Horn and his ice-making truck neighboring La Mansana de Chinati/The Block. Additional Marfa concerns primarily consist of news articles and notes on a proposed prison in Marfa and the arrest of Presidio County Sheriff Richard Dee Thompson for drug smuggling. General files reflect Judd's peace and antiwar interests, political party support, labor and economic issues, water rights, and artists' rights. Extensive civic-related correspondence and donations can also be found in the Incoming Judd Correspondence and the Expenditures section. There are also several files of political publications related to socialism, Marxism, and communism and a wide assortment of printed material.

**Subseries D. Collected Material, 1909-1993 [bulk 1960s-1990s], undated**

Consisting of a wide assortment of material types, **Collected Material** reflects Judd's interests across a range of subjects.

Material filed in Locations are archival items originally located in one of Judd's spaces (from which they were removed and replaced by surrogates); these have been arranged in alphabetical order by location and consist mainly of ephemera and printed material.

The Interests category includes items that relate to identifiable interests of Judd's, which have been arranged in alphabetical order. These folders indicate a significant interest (bagpipes, cacti, wine) or a small batch of related materials without notations by Judd (Abraham Lincoln, historical Marfa).

The General category gathers select groupings of materials. Ephemera consists of an assortment of items including antique checks, yard signs, stickers, recipes, directions, and small bags. Events comprises three folders of programs and ephemera of events, notably including ephemera from Judd's attendance of a state dinner at the White House in 1975. Printed Material includes pamphlets for businesses, art organizations (Dia Art Foundation, Guggenheim Foundation, non-Judd-related Sikken Prize ephemera, etc.), Russian garden cards, and other assorted printed material. Publications consists of two folders of assorted publications not related to Judd and possibly compiled by him or his studio. (Please see the Printed Material series for a more extensive review of Judd's printed material, both about/by Judd or collected by Judd or his studio.) Several scripts written by Harvey R. Shapiro (the founder of Citizens for Local Democracy; see the Civic Activities subseries) are also included in this section.

Note these items are not exhaustive of Judd's interests.

Also present in this series are **Student and Teaching Records**, the bulk of which are from Judd's time as a student at The College of William & Mary and Columbia University, with a few essays dating to his time as a graduate student at New York University. Items include handwritten and typed essays, exams, loose notes, notebooks, printed material, tuition statements, and transcripts received by Judd Foundation in 2004. Of particular interest are early essays written by Judd as a student of philosophy and art. There is a small amount of material from when Judd worked as a part-time history and shop teacher at Allen-Stevenson School, a private boys school in New York. Note that some very early student records are in the Life Documents category of Personal Records.

**Series VII. Financial, Employee, and Legal Records, circa 1940s-1994, undated

**Financial, Employee, and Legal Records**, the largest series of the Donald Judd Papers, documents the financial and legal obligations of Judd and his studio as well as the individuals working for Judd and, to a lesser extent, the Chinati Foundation. The series contains receipts, bills, tax and insurance documents, accounting records, personnel files, and legal files. These materials cover a large area of Judd's work and personal life, including art fabrication, Judd's personal art collection, travel expenses, daily and studio activities, and property purchases.

The Financials subseries is organized into four categories: Expenditures, Accounting, Taxes, and Insurance. The Employee subseries is organized into two categories: Payroll and Personnel. The Legal subseries is organized into three categories: Law Firms, Individual Issues, and La Junta de los Rios. Each category has a small section of associated general files.

**Subseries A. Financials, 1948-1994, undated**

The **Financials** subseries is the largest of the three subseries and covers a wide range of Judd's financial history including expenditures incurred by Judd, his studio, and employees; studio accounting records; and insurance files.

With 101 boxes reflecting payments made by Judd and his studio, Expenditures is the largest section of the Donald Judd Papers. These records consist of receipts, invoices, bills paid, credit card statements, petty cash vouchers, and reimbursements accrued by Judd, his children, and numerous staff. Often, items are notated with the amount paid and check number. Given the number of people involved in managing Judd's personal and professional activities, original order varies greatly by year and decade. In some years, materials are grouped together by year with a topical focus (e.g., 1981 invoices from Marfa Hardware Company). In later years, expenditures were often grouped together and arranged in sequential order by check number. Later years are also more organized, generally following chronological order and corresponding to the original folder title.

Of note is the difference between bills paid and receipts. Bills paid were typically received by the office/accountant(s) from a business, while receipts were often accrued by staff while traveling or running errands and were used to validate reimbursement or confirm petty cash spent. Additionally, receipts were typically compiled in envelopes with handwritten notes regarding the total amount spent and coding them to a particular accounting category, while bills paid were filed in a folder with the associated check number and accounting category. Receipt envelopes have been compiled together under "Receipts" at the end of each respective year, with the bulk from 1987-1994.

In August 2022, Judd Foundation received 11 boxes of financial material dating from 1967-1979 and 1983 from the Chinati Foundation related to Judd's personal life and studio. These materials are believed to have been stored in the artillery sheds at Fort D. A. Russell and moved and re-stored a number of times. Their found order in 2019 indicates materials were compiled together based on size into large plastic containers. During the processing of the Chinati Foundation's records between 2019-2021, Chinati's archivists organized material in loose chronological order with additional refinement by Judd Foundation staff. For accurate searches, careful attention should be paid to folder dates. Additionally, when possible, Judd Archives added a topical title when one was present; folders with only dates contain a variety of expenditures. A good indication of whether a folder was originally arranged by the studio or came from the Chinati Foundation's deposit is the presence of a

photocopy at the front of the folder. Studio/accounting files often include a photocopy created during processing of the original folder used by the studio. Materials that came from the Chinati Foundation's deposit do not have an original folder, due to the frequency with which that material was moved and re-housed.

Materials from the 1950s-1970s that were not part of the Chinati Foundation's deposit are loosely arranged in chronological order and often have a topical focus (clothing, trips, utilities, etc.). There are numerous folders that contain a mixture of receipts; these have been labeled "General" in the container list. Due to a tax audit in 1975, expenditures from 1974 are particularly well documented compared to other years in this period. These have been further arranged by alphabetical order based on their original folder title. There are also four folders related to travel from 1976 to 1977, including trips to Mexico and Australia. Key materials include American Express statements and folders categorized as Receipts. As previously mentioned, receipts often reflect reimbursements incurred by Judd and his staff, the bulk of which were compiled during trips.

Throughout the 1980s, Judd's financial responsibilities grew, with multiple land and property purchases in Presidio County, increased staff, and extensive travel. Beginning in 1981, due to the hire of Willie Null (Judd's bookkeeper for most of the 1980s), several IRS audits, and a series of accounting firms hired by Judd, a more consistent order was created and maintained.

Due to the volume of files and varying recordkeeping practices, a summary for each year from 1969-1994 is provided below.

A bulk of **1969-1979** [224.1-241.8] consists of materials transferred from the Chinati Foundation. These items were loosely arranged in chronological order and are followed by topical focus folders in alphabetical order. While many of these folders include items for several years, there is typically one year prominent. These files also contain accounting, banking, and tax documents.

All **1974** files were arranged by Judd's studio in chronological and topical order (alphabetically). These materials were most likely arranged in great detail due to a tax audit in 1975.

**1980** has a single file present. A number of expenditures dated 1980 are in the 1979 and 1981 files.

**1981** files are arranged in alphabetical order by their original folder titles, which were primarily titled by business name. In some cases, an additional description has been added by the Archives staff to increase discoverability and provide better context for certain business names.

**1982** files are arranged in a similar alphabetical order as in 1981. These materials were transferred from the Chinati Foundation.

**1983-1985** files are arranged by property. This new arrangement was most likely implemented by an accounting firm due to an IRS audit. The bulk of the folders contain a general ledger sheet summarizing yearly expenses by property.

**1986** only contains three files: property taxes paid, a file with bills related to Judd's ranches, and general receipts accrued by the studio.

Beginning in **1987**, the volume of bills, invoices, and receipts increased substantially. Additionally, the arrangement reverts to an alphabetical order based on original folder titles, which were primarily titled by business name. As with material from 1981, an occasional descriptor was added to unclear business names for better context and clarity. Starting in 1987, the files demonstrate a more robust recordkeeping practice in which employees directly maintained their receipts, primarily for travel (taxis, restaurants, hotels) or errands grocery stores, gas, postage, and various bills paid with petty cash or by the employee's personal funds and kept for reimbursements). The bulk of the receipts in 1987 were organized chronologically, rather than topically, with additional receipts organized by travel or by reimbursement by employee name. Studio and travel folders were arranged in loose chronological order, while reimbursements were arranged in alphabetical order by last name.

**1988** files follow a similar pattern to 1987. Most of the folders are arranged in alphabetical order by original folder title. In some cases, there are several files for one business such as American Express; these files were arranged alphabetically. Receipts for this year are mostly arranged in chronological order with some folders related to Donald Judd or Ellie Meyer.

**1989** represents another major shift in recordkeeping by the Judd studio. Instead of individual files for a single business or event, the studio (and their bookkeeping firm) organized bills and invoices in sequential check number. As the year progressed, folder titles better represent what is present in each folder. Receipts for this year follow a similar pattern as 1988, with general and travel receipts arranged chronologically. Additional folder description, such as places visited, was added to the travel folders for increased discoverability. There are additional folders that fit neither general nor travel categories and were arranged at the end of the receipts section. These include check request forms (with no invoices or bills included) and petty cash reports.

**1990** follows a similar pattern to 1989. Bills paid are arranged by the check number used to pay them and include a range noting when the payment was made. There are two individual business files for ArtSource, a framing company used by the studio for Judd's personal collection and for artwork in the collection of the Chinati Foundation, and a second folder for the shipping company L.A. Packing and Crafting. The items associated with ArtSource were likely compiled around 1993, but the bulk of the material is dated 1990. The bulk of receipt folders for 1990 relate to travel by Judd and his staff. There is a small quantity of general folders and several petty cash reimbursement folders.

**1991-1993** are similar to 1989 and 1990, with variation in the organization of receipts. Beginning in 1992, check request forms and reimbursements/petty cash were included with bills paid. The bulk of the receipt folders are for travel. For 1991, there is a single general folder and three folders related to Judd's Chase Manhattan Bank account. There is one folder of check request forms and one for petty cash. By 1992, check request forms were largely phased out. Receipt folders in 1992 are primarily travel related. Also in 1992 is a small quantity of folders related to purchases/payments made by Judd's assistants. Receipts from 1993 are also a blend of travel-related and general folders. Additional information (travel locations and date spans) were added for greater clarity and discoverability.

**1994** expenditures are minimal, given Judd's death in mid-February. There is only one check folder, a single folder of bills from AT&T (bulk late 1993), and two general receipts folders. Expenditures after Judd's death can be found in the Donald Judd Estate and Early Judd Foundation Records. Please note that there are extensive lifetime receipts in the Donald Judd Estate and Early Judd Foundation Records due to partial payments made by the studio following Judd's death.

The Books section includes invoices for books purchased by Judd. Files include a folder with pre-1983 invoices with a bulk dated 1968 and 1981, arranged by Dudley Del Balso as "Library Marfa." There is a folder of late 1980s invoices arranged alphabetically by publisher. Lastly, two folders contain the files from an inventory conducted by the Estate after Judd's death. These files were moved from the Estate and Early Foundation Records since they contain a sizable number of lifetime invoices.

There is a discrete section of Shipping files containing receipts and invoices regarding the transportation of Judd's artwork and personal items between Europe, New York, and Marfa, the bulk of which date from the late 1980s and early 1990s. These have been retained as is, due to their fluctuating filing structure (sometimes filed by company, location, or year).

The last section of Expenditures is Third-Party Receipts from Julie Finch, Judd's wife from 1964 to 1976. These consist of receipts and banking records, dating primarily from the late 1960s to the 1970s. Additionally, there are receipts from Marianne Stockebrand (Judd's partner from 1988-1994) related to Judd's art practice in Cologne, Germany.

Any files outside these established structures were carefully reviewed to determine their appropriate placement. Throughout Expenditures, files were moved to support greater consistency and arrangement clarity.

The second category of Financials are Accounting records generated by the studio, banks, and the accounting firms hired by Judd. These files have been divided into two sections: Ledgers and Banking. Ledgers have been arranged in chronological order and primarily reflect general ledgers but also include bank-specific ledgers, as well as different types of reports (adjusted ledgers, working balances, balance sheets, etc.) created by accounting firms and the studio. Payroll ledgers are located in the Employee subseries.

Banking records are arranged in chronological order. Between 1957-1972, Judd primarily used Chemical Bank and Bankers Trust in New York. Following his move to Texas in the 1970s, his primary bank was Marfa National Bank until 1989, when the studio switched to First International Bank in Alpine. Judd also frequently used Chase Manhattan Bank throughout the 1980s. Also present are retirement (Dreyfus) and investment fund statements, as well as some European bank files (Schw. Bankgesellschaft, Oppenheimer) from the early 1990s. The bulk of banks outside the ones identified as primary only include bank statements. A small quantity of check stubs were used by law firms during the years preceding Judd's death for estate and legal matters. These were arranged in chronological order at the end of the section.

Judd's tax records are arranged in loose chronological order. The inconsistency of this arrangement is partially due to Judd's frequent and years-long audits by the IRS, which led to materials being mixed, especially by year. For example, Judd's 1975 audit was ongoing into the early 1980s. Early 1950s and 1960s tax documents are intermixed, as are the bulk of the early to mid-1970s taxes. Additionally, a sizable portion of material from the 1950s-1970s came from the August 2022 transfer from the Chinati Foundation. These items were also arranged in loose chronological order. As much as possible, the type of tax has been included in the container list description for additional clarification.

Insurance files were arranged in loose chronological order by the studio with further refinement for improved accessibility. Files were typically arranged by type of insurance, with the occasional folder arranged by company (Brownstone, Livingston, etc.). Additional topical information was added for improved description when necessary. As is common in the Financials subseries, materials from the 1950s-1970s are less arranged than those in the late 1980s and early 1990s.

There is a small quantity of general files that primarily consist of correspondence between the studio and accounting firms arranged chronologically by firm, as well as a few informational files pertaining to tax, gift, and artist legislation. Additionally, there is a small quantity of informational material for grants.

Other areas of the Donald Judd Papers that relate to the Financials subseries include Objects; Architecture and Spaces; and the Museums, Galleries, and Collectors series. Refer to these areas for a more complete picture of Judd's financial activities.

Printed Material is a vast and encompassing documentation of printed material about and by Judd and his art, as well as printed material collected by Judd and his studio.

**Subseries A. Periodical Publications by or about Judd, 1939-1994, undated**

Periodical Publications by or about Judd includes texts authored by the artist and texts on his work that were published in a variety of periodical formats. Clippings consist of articles about Judd that were cut out of periodicals. They have been arranged chronologically. The earliest examples of clippings (1952-1957) were pasted to pages in the manner of a scrapbook and have been kept in original order. The clippings are generally in good condition; delicate items have been photocopied and placed in polyester sleeves for protection. The folder of Dudley Del Balso's 1981 notes describes the original organization of some of the clippings included here, though this arrangement no longer exists.

Clippings of interest kept by Judd and his studio can be found in the category Published Material (not by or about Judd).

The Magazines category includes magazines with articles by and about Judd, as well as magazines of interest to him. A majority is art magazines, including early publications with Judd's art criticism and reviews. They have been arranged chronologically and are in good condition.

Newspapers in this section include articles about Judd as well as advertisements for his early exhibitions, and are made up of international, national, and regional publications. Newspapers were previously organized by regional and nonlocal sources and are now combined and arranged chronologically. Whole newspapers and full pages were put into oversize boxes, whereas smaller excerpts were put into Clippings. They are generally in good condition, with some earlier examples in slightly brittle condition. Multiple copies of newspapers with an important article have been kept, such as the February 13, 1994, edition of the *New York Times* containing Judd's obituary.

### **Subseries B. Collected Printed Material, 1939-1994, undated**

**Collected Printed Material** includes similar materials to the previous subseries such as clippings, newspapers, magazines, but is more extensive in its content. Other items include postcards, maps, and non-Judd exhibition ephemera.

Clippings covers a variety of topics and has been arranged chronologically. A number of these clippings have minimal notations by Judd, such as year or "Info." Additionally, there are four boxes of photocopied clippings on philosophers, which have been arranged alphabetically by last name. A small section of clippings arranged by Judd has been maintained as is. A bulk of these clippings (which also includes a very small amount of complete publications) is notated by Judd and includes correspondence and notes, including a small section of publicity related to the Phoenix Art Museum's 1987 Biennial. Other topics in these two boxes include the Persian Gulf Wars, U.S. politics and military, art, and other U.S. current topics.

Catalogues, Manuals, and Guides covers a wide range of materials and has been arranged topically.

Non-Judd Exhibition Ephemera consists of ephemera relating to art exhibitions by artists other than Judd. The ephemera comes from a range of galleries, predominately in New York in the 1960s, and includes artists of interest such as Josef Albers, Carl Andre, Yayoi Kusama, Frank Stella, and Andy Warhol, among many others. These items have been arranged chronologically and are in good condition. Any solo show ephemera from artists also present in the Artists Files was moved to their individual folders.

Maps have been arranged by location and in order by most prevalent. A fair number of materials are oversize and occasionally include notations by Judd. Note a large number of maps are in situ in Judd Foundation spaces and are not included.



Postcards have been compiled and arranged typically including specific location; art; objects; and aerospace. The first folder, "England; France; Sweden; United States," has been arranged as found due to a likelihood of original order established by Judd.
